RE: July 15, 2020, Virginia Freedom of Information Act Requests by Jessie Higgins

Dear Mr. Giaramita:

We write in connection with four requests by Charlottesville Tomorrow reporter Jessie Higgins under Virginia's Freedom of Information Act ("VFOIA"), Va. Code Ann. §§ 2.2-3700-3715 (2020), to the Albemarle County Public Schools, which she transmitted by email on July 15, 2020, and with respect to which you confirmed receipt on the same day. Copies of those emailed requests are attached to this letter.

The statutory timeline for responding to VFOIA requests is clear. Any public body must respond within five work-days of receiving a request. § 2.2-3704(B). If it is not practically possible to provide the requested records or to determine whether they are available within the five-work-day period, the public body is obligated to explain why a response within that period is impossible. § 2.2-3704(B)(4). The public body may then take an additional seven work-days to produce the documents, explain whether and why they are being withheld (in whole or in part, and then explain why segregable portions are being withheld), or whether the documents cannot be found or do not exist. § 2.2-3704(B)(1)-(4). By our count, the last day of that sevenwork-day period is July 31, 2020.

VFOIA permits any "public body [to] petition the appropriate court for additional time to respond to a request for records when the request is for an extraordinary volume of records or requires an extraordinarily lengthy search, and a response by the public body within the time

required by this chapter will prevent the public body from meeting its operational responsibilities." § 2.2-3704(C). To our knowledge, the Albemarle County Public Schools has not petitioned an appropriate court for additional time, nor has it sought to make reasonable efforts to reach an agreement with Higgins concerning the production of the material requested, as would be required before proceeding with a petition.

You stated in your responses to Ms. Higgins's four requests that "under an emergency governance ordinance enacted by the Board of Supervisors pursuant to an opinion by the state Attorney General, the response time requirements for FOIA requests have been lifted." *See, e.g.*, Email from Phil Giaramita to Jessie Higgins (July 15, 2020; 14:20 EST). We understand that the ordinances to which you refer are Emergency Ordinances No. 20-A(6) and No. 20-E(2).

Your statutory obligations under VFOIA, however, cannot be waived by an emergency ordinance, and we accordingly respectfully request that you comply with these statutory obligations. Unlike the section of VFOIA governing official meetings held electronically, § 2.2-3708.2, which does expressly provide for remote meetings in some circumstances upon the declaration of an emergency, there are *no* emergency exceptions in VFOIA that permit a public body to modify the time by which it must reply to VFOIA requests.

Furthermore, the Attorney General's opinion that you apparently reference emphasizes the "limits of the authority" conferred by Va. Code Ann. § 15.2-1413, the "continuity of government" provision, which requires that any ordinances enacted pursuant to its authority be "carefully limited in scope." *See* Official Advisory Opinion from the Office of the Attorney General to the Honorable Richard C. (Rip) Sullivan, Jr. (Mar. 20, 2020), 2020 WL 1550202. A blanket exemption from VFOIA's deadlines is unlikely to qualify as "carefully limited" particularly in light of the fact that the vast majority of public bodies in Virginia, including the Governor's office and the Virginia Department of Health, continue to process VFOIA requests in a timely fashion. *See also* Va. Code Ann. § 2.2-3700(B) ("Any ordinance adopted by a local governing body that conflicts with the provisions of [VFOIA] shall be void.").

We certainly understand the complications that may be posed by requests that include material requiring a physical search and we stand ready to work with you to find a mutually satisfactory resolution to the extent a physical search for documents is required. But for
